Jigawa State Government Has Constructed New General Hospitals at Gagarawa, Gwiwa and Kirikasamma, and Specialist Hospitals at Hadelia and Kazaure. The Ministry intends to supply and install Medical Equipment to these hospitals through e-procurement.

In Compliance with Jigawa State Procurement law NO. 13 of 2019, Jigawa State Ministry of Health wishes to notify the interested bidders wishing to participate in the process,

2 PROJECT SCOPE:

The Scope of the project is as follows

LOT 1: Supply, Installation and Training of Medical Equipment to Gagarawa New General Hospital.

LOT 2: Supply, Installation and Training of Medical Equipment to Gwiwa New General Hospital

LOT 3: Supply, Installation and Training of Medical Equipment to Kirikasamma New General Hospital

LOT 4: Supply, Installation and Training of Medical Equipment to Hadejia Specialist Hospital

LOT 5: Supply, Installation and Training of Medical Equipment to Kazaure Specialist Hospital.

3 ELIGIBILITY REQUIREMENTS

Bidding document should be submitted along with the following documents:

- I. Certificate of Incorporation with Corporate Affairs Commission
- II. Certified True Copy of Memorandum and Article of Association
- III. Evidence of registration with Jigawa State Works Registration Board
- IV. Tax clearance certificate for the last three (3) years
- V. Audited Account for the Last One (1) Year
- VI. VAT Registration and Evidence of Past Remittance
- VII. Evidence of financial capability and banking support
- VIII. Company's Average Annual Turn Over of not less than N150 Million
- IX. That the Company have fulfilled all obligations to pay taxes, pensions, ITF Contribution and social security contributions
- X. Evidence of execution and completion of similar Projects at least 3 in the last 5 years
- XI. Verifiable evidence of Company profile and technical qualification of key personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON etc.
- XII. A sworn affidavit certifying as Follows:
 - a) That the document submitted for the pre-qualification exercise are not only genuine but correct
 - b) That none of the directors of the Company has been convicted by any court of law
 - c) That the Company is not bankrupt.
 - d) That none of the officers of Jigawa State/Local Government is a present or former director of the Company.
- XIII Any other relevant information that will help in determining the Company's suitability for the work.

2. Company are to submit their bids on Jigawa state e-procurement portal (<https://jigawa-eproc.eurodyn.com/epps/home.do>) on or before Tuesday, 17th January, 2023
3. A scanned copy of bid security of not less than 2% of the bid price either in form of insurance bond or bank guarantee addressed to **Honorable Commissioner,**

Ministry of Health Jigawa State, Dutse, Jigawa State should also be uploaded into the portal.

4. Prequalification and financial bids should be submitted in two different sealed envelopes, (1 original and 2 photocopies in a bigger envelope) addressed to the Honorable Commissioner Ministry of Health, block B New Secretariat Complex, Takur Dutse.
5. Similarly, the original of company's profile, signed forwarding letter with attached bill, bid security and a copy of the sworn Affidavit in hard copy should be sent to **Honorable Commissioner, Ministry of Health Jigawa State, Dutse, Jigawa State**
6. Bids shall be valid for a period of **120 days (4month)** after Bid opening.
7. Bids submitted after the deadline for submission will be returned un-opened.
