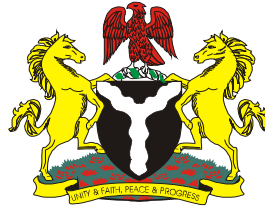


INVITATION TO BID

INVITATION TO PREQUALIFICATION AND TENDER IN RESPECT OF SUPPLY AND INSTALLATIONS OF MEDICAL EQUIPMENT TO NEWLY UPGRADED PRIMARY HEALTH CENTRES TO GENERAL HOSPITALS ACROSS THE STATE

a. PREAMBLE

The Government of Jigawa State in its effort to increase efficient and effective health care service delivery in the State, hereby invites tenders from reputable contractors for the above named projects

A. SCOPE OF WORK

The projects are divided into lots 1, 2, 3, 4 ,5, 6, 7, 8, 9, 10 and 11 as per details below: -

LOT1: Fagam General Hospital, LOT2: Gwaram, LOT3: Auyo, LOT4: Sule Tankarkar LOT5: Kiyawa, LOT6: Kanya Babba, LOT7: Bulangu Cottage, LOT8: Karkarna, LOT9: Roni, LOT10: Kaugama, LOT11: Supply and Installations of Xray Machine and accessories to five (5) General Hospitals at Babura, Ringim, Dutse, Kafin Hausa and Gumel.

B. ELIGIBILITY REQUIREMENTS

Bidding document should be submitted along with following documents:

- I. Certificate of Incorporation with Corporate Affairs Commission
- II. Certified True Copy of Memorandum and Article of Association
- III. Evidence of registration with Jigawa State Due Process and Project Monitoring Bureau
- IV. Tax clearance certificate for the last three (3) years
- V. Audited Account for the Last One (1) Year
- VI. VAT Registration and Evidence of Past Remittance
- VII. Evidence of financial capability and banking support

- VIII. Company's Average Annual Turn Over of not less than N100 Million
- IX. That the Company has fulfilled all obligations to pay taxes, pensions, ITF Contribution and social security contributions
- X. Evidence of execution and completion of similar Projects at least 2 in the last 5 years
- XI. Verifiable evidence of Company profile and Technical Qualification of key personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON etc.
- XII. A sworn affidavit certifying as Follows:
 - a) That the document submitted for the pre-qualification exercise are not only genuine but correct
 - b) That none of the Directors of the Company has been convicted by any court of law
 - c) That the Company is not bankrupt.
 - d) That none of the officers of Jigawa State/Local Government is a present or former director of the Company.
- XIII Any other relevant information that will help in determining the Company's suitability for the work

C.COLLECTION AND SUBMISSION OF TENDER DOCUMENTS.

Bidding Documents could be obtained through Jigawa state e-procurement portal (<https://jigawa-eproc.eurodyn.com/epps/home.do>) upon payment of non-refundable fee of Five Hundred Thousand Naira only (N500,000) only to the state ministry of health.

D.SUBMISSION OF TENDER DOCUMENT

- I. Company are to submit their bids on Jigawa state e-procurement portal (<https://jigawa-eproc.eurodyn.com/epps/home.do>) on or before 10th November 2022 by 12:00 Noon.
- II. The Opening date is Thursday 10/11/2022 By 12:00pm
- III. A scanned copy of bid security of not less than 2% of the bid price either in form of insurance bond or bank guarantee addressed to **Honorable Commissioner, Ministry of Health Jigawa State, Dutse, Jigawa State** should also be uploaded into the portal.
- IV. Prequalification and financial bids should be submitted in two different sealed envelopes, (1 original and 2 photocopies in a bigger envelope) addressed to the Honorable Commissioner Ministry of Health, block B New Secretariat Complex, Takur Dutse.
- V. Similarly, the original of company's profile, signed forwarding letter with attached bill, bid security and a copy of the sworn Affidavit in hard copy should be send to **Honorable Commissioner, Ministry of Health Jigawa State, Dutse, Jigawa State**

- VI. Bids shall be valid for a period of **120 days (4month)** after Bid opening.
- VII. Bids submitted after the deadline for submission will be returned un-opened.

F. GENERAL INFORMATION

However, bidders should note the following information: -

- 1 Bids submitted after deadline for submission will be denied access to the portal
- 2 Only financial bids of successful pre-qualified bidders will be opened.
- 3 This advert shall not be construed as commitment on part of the Jigawa State Ministry of Health, nor shall it entail a Company to make any claim(s) whatsoever and/or to be any indemnity from the Jigawa State Ministry of Health by Virtue of such Company having responded to this advertisement.
4. Bidders with the same subsidiary relationship are not allowed to partake in the same lot.
- 5 All cost will be borne by the bidders as the Jigawa state Ministry of Health will not be held responsible for any cost or expenses incurred by any interested party i.e. in connection with any response to this invitation.
- 6 The jigawa State Ministry of Health reserves the right to annul the procurement process at any time without incurring any liabilities
- 7 No Bidder is allowed to participate in more than 3NO Lots.
