# INVITATION FOR PRE QUALIFICATION/INVITATION TO TENDER 2024 CAPITAL PROJECTS

In line with His Excellency Governor Umar A. Namadi's 12 point Agenda among which is the provision of Electricity for Urban and Rural Transformation, the Jigawa State Rural Electricity Board is hereby inviting interested Companies to bid for the Construction of Electrification projects.

## **SCOPE OF WORKS**

4	Construction of 33kv Inter Town Connection (ITC) Line from Majia to Ringim in Taura/ Ringim LGA

- 3. Certificate of National Pension Commission (PENCOM) for the last one year
- 4. Certified true copy of memorandum and article of association
- 5. Tax clearance for the last three (3) years
- 6. Evidence of registration with Jigawa state Due Process and Project Monitoring Bureau works registration (Electrical)
- 7. Registration with Jigawa State Ministry of Commerce (Business Premises)

- 8. Company's audited account for the last one (1) year
- 9. Evidence of financial capability and Banking support
- 10. Company's profile including names of key professional personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON) etc.
- 11. Evidence of similar projects executed (letter of award and completion certificate) at least three (3) within the last five (5) years.
- 12. Description and list of relevant Electrical works equipment
- 13. Company average annual turnover of not less than N20m
- 14. VAT registration and evidence of past remittance(s)
- 15. A sworn affidavit certifying as follows:
  - i) That the document submitted for the prequalification exercise are not only genuine but correct
  - ii) That none of the director of the company has been convicted by any court of law
  - iii) That the company is not bankrupt
  - iv) That none of the officers of Jigawa State/Local government is a present or former director of the company

### **COLLECTION OF TENDER DOCUMENTS**

Interested bidders would be required to pay a non-repondable Tender fee of  $\maltese$  150,000 for lot 1 &3  $\maltese$  300,000 for lot 2 and  $\maltese$  500,000 for lot 4, and collect Tender documents which includes Standard Bidding Document (SBD), GCC and Bills of Quantity at the office of Procurement Officer (Secretary Tender Committee) Rural Electricity Board Block B 3<sup>rd</sup> flor New Secretariat Complex Dutse Jigawa State.

### SUBMISSION OF TENDER DOCUMENT

Prospective bidders are to submit pre-qualification documents, filled SBD and two(2) copies of Technical bid. Similarly, the original and (2) copies of company's financial Bid signed by Managing Director of the company's letter headed paper with attached bills, 2% of bid security from Insurance bond or Bank guarantee acceptable by Jigawa State Due process, and address to the Managing Director Rural Electricity Board Dutse. Indicate the lot number and project title and submit to the office of the Secretary Tender Committee (Procurement office) Rural Electricity Board Dutse not later than 6 weeks from the date of this publication.

Bids shall be valid for a period of 120 days from the deadline of the bid submission date.
