1. PREAMBLE

In compliance with Jigawa state procurement process, the State Rural Water Supply and Sanitation Agency (RUWASSA) wishes to notify interested bidders of its intention to procure Four Hundred and Eighty Six Hand Pump boreholes, Sixty One Water Collection points, Conversion of Twenty Two generator water point to solar and completion of four water system across 36 political constituencies in the state

2. **PROJECT SCOPE**

Construction Four Hundred and Eighty Six Hand Pump boreholes, Sixty One Water Collection points, Conversion of Twenty Two generator water point to solar and completion of four water supply system divided in to 45 lots shown below;

3. ELIGIBILITY REQUIREMENTS

To be considered for the pre qualification, interested component and reliable contractors are required to provide verifiable evidence including but not limited to the following documents;

- i. Certificate of incorporation with Corporate affairs Commission
- ii. Certified true copy of memorandum and article of association
- iii. Tax clearance for the last three years
- iv. Evidence of Registration with state works registration unit
- v. Company's audited account for the last one year
- vi. Evidence of financial capability and Banking support
- vii. Verifiable evidence of company profile and technical qualification of key personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON etc;

viii. That the company have fulfilled all obligations to pay taxes, pensions and social security contributions;

xi sworn affidavit certifying as follows:

- a. That document submitted for the prequalification exercise are not only genuine but correct
- b. That none of the director of the company has been convicted by any court law
- c. That company company is not bankrupt
- d. That the none of the officers of Jigawa State/Local government is a present or former director of the company

viii. Description and list of relevant construction/building equipment

x. VAT registration and evidence of past remittance

xi Any other relevant information that will help in determining the company's suitability for the work
Any prospective bidder that does not possess any of the documents need not apply

4. COLLECTION OF TENDER DOCUMENTS

Interested bidders are to collect the tender documents from the office of the Managing Director Jigawa state, RUWASA Dutse from the date of publication of this advert and between hours of 9:00am to 4:00pm daily after payment of a non-refundable fee of Twenty Thousand Naira only (N20, 000).

5. SUBMISSION OF TENDER DOCUMENT

Pre- qualification and financial bids shall be submitted in two different sealed envelopes and labeled "pre -qualification bid" and "financial bid" respectively with the company's name indicated at the back of each envelope. Both envelopes should be placed in a sealed third envelope addressed and delivered to the office of the Managing Director Jigawa state RUWASA and not later than 21st December 2020 by 12.00 noon.

All documents for submission must be transmitted with a forwarding letter dully signed by the representative under the company's Letter Headed paper bearing the CAC Registration Number (RC), Contact Address, Telephone Number, (preparably GSM No) and e-mail address

The financial bid should contain a bid security of not less than 2% of the quoted bid

The validity period should be 90 days from the deadline of the bid submission date

6. OPENING OF BIDS

Only technical bids shall be opened immediately after the deadline of the bid submission date

7. GENERAL INFORMATION

I Bids submitted after deadline for submission will be returned un- opened;

li Only the financial bids of successful pre qualified bidders will be opened, while those for the un-successful bidders will be returned un-opened;
