  - III. Certified TRUE COPY OF Memorandum and article of Association
  - IV. Evidence of registration with Jigawa Stated Works Registration Board
  - V. Tax Clearance certified for the last three (3) years (2019, 2018 & 2017)
  - VI. Audited account for the last one (1) year
  - VII. Evidence of payment of Tax /Tax identification number
  - VIII. Evidence of financial capability and banking support
  - IX. Evidence of successful Execution of similar job(s)in the past in form of verifiable list of projects in Nigeria
  - X. Evidence of company turn over of not less than N200 million.

Financial Bid must be accompanied by 2% security which shall be Valid for at least 120 days after the Bid Opening All Document shall be delivered to the office of the permanent Secretary Government House Dutse on or before 12 noon of Wednesday 16<sup>th</sup> November 2020 at which time the bid-Opening exercise would commence in presence of bidders and other interested stakeholders who wish to attend
